Public Health



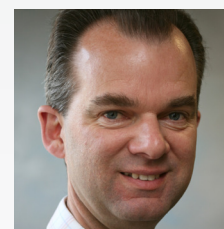
Professor David Walker: Regional Director of Public Health for the East Midlands. Previously acting Regional Director of Public Health for the North East Region.
